- The cover letter for financial submission must carry information such as tender sum, completion period and tender validity.
- Qatar Charity deducts 5% Withholding Tax at Source on all Supplies and 10% on all Services rendered and remitted to the Federal Inland Revenue Service (on behalf of a vendor) asstipulated by the Federal Government of Nigeria Tax Law.
